

Streetbeat Refer-a-Friend Referral Disclosure Statement

Effective as of July 28, 2023 (the "Effective Date")

You have received a designated referral or promo code ("Code") to participate in this Refer-a-Friend program (the "Program"). In order to participate, you must open an advisory account ("Account") with Streetbeat LLC ("Streetbeat"), subject to the [Streetbeat Advisory Agreement](#) ("Advisory Agreement"), in accordance with these terms and conditions ("Program Terms"). Your referring friend who sent you a Code ("Referrer") must be a Streetbeat customer and has done so through this Program. This invitation does not constitute a statement of your friend's experience with, or endorsement of Streetbeat.

Eligibility

To participate in this Program and receive a subscription credit (a "Referral Credit") hereunder, you must be 18 years or older and reside in a jurisdiction where Streetbeat is authorized to do business. Additionally, you must complete the designated registration process for opening an Account and your Account must be approved and be and remain in good standing (as described below). Further, once approved for an account you must pay a subscription fee ("Subscription Fee") in order to receive advisory service"). To constitute an "Account" hereunder, you must complete the designated registration process for opening an Account by using your special designated Code included in your invitation, and Streetbeat must approve the opening of your Account.

Only one Referral Credit will be awarded for each person who opens an Account by using their designated Code. You will not earn a Referral Credit if you have an existing Account or if you do not use the correct Code. You must be able to personally identify the person who referred you and sent you the Code.

Streetbeat reserves the right to determine in its sole discretion whether an Account is closed and/or in good standing. An Account in good standing for purposes of this Program is an Account for which all required account opening documentation has been completed and verified, and is not locked, restricted, limited, terminated, or otherwise flagged in any way. If either Account is closed or not in good standing for any reason at any time, any Bonus will be forfeited.

Streetbeat reserves the right to disqualify anyone from the Program at any time. Anyone who violates these Program Terms is ineligible for a Referral Credit. Streetbeat reserves the right to change or cancel the Program at any time, and to change the eligibility for the Program at any time.

Free Trial Periods

Subject to these Program Terms, after you open and are approved for an Account and pay a Subscription Fee, Streetbeat will award you in the form of a Referral Credit. As shown in the

chart below, you will earn a Referral Credit in the form of a trial subscription credit (“Trial Credit”).:

Trial Credit	Thirty (30) day Trial Subscription Period*

*Trial Subscription Period means the number of days in a trial period in which a Friend may use the Streetbeat App (as defined below) and receive services from Streetbeat without paying any Fees. If there is already a free trial period applied to the account, the Free Trial Period will be reduced by the number of days the account has been using the free trial.

For each Eligible Referral, your Referral Credit will be delivered automatically to your Streetbeat Account.

Referral Invitations

Any referral Codes that either (i) were received prior to the Effective Date where you have not as of the Effective Date created unique login credentials with Streetbeat (e.g. username and password), or (ii) are received on or after the Effective Date, will expire one-hundred and eighty (180) calendar days from the date that you create unique login credentials with Streetbeat (e.g. username and password). If your referral Code expires and you have not already created unique login credentials with Streetbeat (e.g. username and password), then you will be eligible to receive future referral Codes valid under this Program. If your referral Code expires after you have already created unique login credentials with Streetbeat (e.g. username and password), then you will not be eligible to receive any future referral Codes from (or earn a Referral Credit) under this Program.

If we make any material changes, we will notify you by email (sent to the email address specified in your Account), by means of a notice on the Streetbeat mobile app and website prior to the change becoming effective, or as otherwise required by law. Notwithstanding anything herein, we do not have to provide you with prior notice of any amendments to the Program that are beneficial to you. Your continued access to or use of the Program after we make any changes to these Program Terms will be subject to the revised Program Terms, and you will be deemed to be aware of and bound to the revised Program Terms by your continued access to or participation in the Program. If you do not accept any such revisions or changes, your sole and exclusive remedy is to cease participation in the Program. The Program may be canceled at any time without notice to you.
