1. Acceptance of Terms

By accessing or using Streetbeat's services, provided by Nowcasting.ai INC dba Streetbeat ("Streetbeat", "we", "us", or "our"), you agree to be bound by these Terms of Use ("Terms"). If you disagree with any part of the terms, you may not access the service.

2. Description of Service
